Overview of Draper Community Visits

The draft Municipal Development Plan (MDP) is being finalized to present to Council. Before that happens, we asked for your feedback on Draper considerations in the draft MDP.

Broad public engagement about the MDP occurred in numerous phases including, Fall 2020, Winter 2021, and this past winter finishing on March 13, 2022. However, some Draper residents requested further opportunity to provide targeted feedback about how the MDP specifically relates to Draper. The following is a high-level summary of how we engaged with you and your feedback.

- Community visit dates: May 16 20, 2022
- Two teams of two Public Engagement staff members went door to door providing;
 - \circ $\;$ Information packages given to residents who were home
 - o Information package dropped off at residences where nobody was home
 - \circ $\;$ Information packages were mailed to property owners that reside elsewhere
- Online feedback form open: May 16 May 28
 - \circ $\;$ Late submissions accepted until June 7 to support mailout submissions $\;$
- 57 feedback forms submitted by Draper property owners
